- 1. Receive comments from the public;
- 2. Review and approval of minutes of the May 19, 2025, meeting of the Board of Directors;

- 4. Authorize preparation and maintenance of a local government officers list in connection with conflict of interest disclosure requirements;

- 6. Consider and accept excess collections for 2024 debt service and certification for debt service collection rate for 2025/2026;
- 7. Consider and act upon the engineer's report, including:
  - (a) Authorizing the design, advertisement for bids and/or award of construction contracts, and the acceptance of Texas Ethics Commission Form 1295;
  - (b) Status of construction contracts, including the approval of any pay estimates or change orders, including:
    - 1) Woodlands Parkway at Grogan's Mill Road Intersection Project (the "Project"); and
  - (c) Approval of construction inspection proposal for the Project;
- 8. Consider and act upon developer's report;
- 9. Status of proposed annexation of lands to and/or the exclusion of lands from the boundaries of the District and authorize any action necessary in connection therewith;

- 10. Consider and act upon reports from the District's attorney, financial advisor and tax assessor/collector;
- 11. Authorize competition, execution and filing with the Secretary of State of Voting System Annual Filing Form relative to District elections;
- 12. Request from Records Management Officer to destroy certain records of the District;
- 13. Consider and act upon financial and investment reports, and approval and/or ratification of the payment of invoices;
- 14. Recess to closed session pursuant to Section 551.071, Texas Government Code;
- 15. Reconvene in open session and authorize any action resulting from closed session; and
- 16. Such other matters as may come before the Board of Directors.
